Invited Session 2

Experimental Economics: Moving Forward with Applications to Environmental and Resource

This session highlights the research of two of the Northeast's young faculty, Jim Murphy and Chris Anderson. Their research is designed to extend experimental economics to address important issues in the environmental and natural resource areas. The session will begin with a brief overview of experimental economics. Jim and Chris will then provide two examples to illustrate application to environmental and resource issues.

Hypothetical Bias and Contingent Valuation: What's Going on Here? Dr. James Murphy, Department of Resource Economics, University of Massachusetts.

The presence of hypothetical bias in contingent valuation is well documented, and some calibration techniques have been successful at reducing or removing this bias. However, the underlying causes of hypothetical bias are not well understood. Recent efforts to use laboratory experiments to test hypotheses about potential sources of this bias will be presented. (with coauthors Tom Stevens and Michael Ash).

Effort Consolidation under Tradable Fishing Allowance Programs. Dr. Chris Anderson, Department of Environmental and Resource Economics, University of Rhode Island.

With the recent expiration of a federal moratorium, many U.S. fisheries are now considering management programs that allow trading of fishing allowances. One frequent concern among stakeholders is that allowance markets lead to industry consolidation, and the loss of small family fishing operations. This paper will discuss results from a controlled laboratory experiment that assesses determinants of effort allocation and consolidation under a tradable trap certificate program in the Rhode Island lobster fishery.

WEDNESDAY JUNE 23

NAREA/CAES Workshop on International Trade and the Environment

The goal of this workshop is to stimulate research and discussion to improve our understanding of the complex interrelationships between international trade, natural resource use, and the environment. BIO-ENERGY IN NORTH AMERICA: PROBLEMS, POLICIES, AND POTENTIAL

Session organizer: Kurt Klein, University of Lethbridge

Economic incentives and constraints are key issues for Canada and the US. This session is intended to encourage debate on the problems and policies related to the development of bio-based energy in Canada and the US, and to improve understanding of the potential role of bio-fuels in boosting energy supplies and alleviating greenhouse gas production.

Session Organizers: Paul J. Thomassin and Paul Atkinson, McGill University

Recent clarifications of the Kyoto Protocol at the Conference of the Parties (COP 7) recognized that agricultural soils can be included as a carbon sink along with afforestation and reforestation. As a result, the biosphere can potentially play an important role in satisfying our GHG commitment. A major funding initiative was put forward by BIOCAP and SSHRC to investigate the potential for management of the biosphere for GHG. This principal paper session will report initial research results of the six nodes in the Network.

WHAT'S HAPPENING IN THE CO-OPERATIVE SECTOR?

Session Organizer: Ellen Goddard, University of Alberta

Despite significant structural change over the past twenty years the co-operative sector remains a significant component of the North American economy. However, agri-business sectors that were previously dominated by co-operatives are seeing the co-operative market share change significantly. The Canadian dairy processing and grain handling sectors are prime examples of this. On the other hand, upply co-operatives seem to be growing and in most cases, prospering. The papers in this session relate to various aspects of co-operatives in North America, from management issues to historical overviews of what has actually happened to specific co-operatives.

THE ECONOMICS OF THE CANADIAN AGRICULTURAL INCOME SUPPORT PROGRAM

Session Organizer: Al Mussell, George Morris Centre

There are material differences between the new CAIS program and its predecessors. Little is known about the incentives, effectiveness, or effects of CAIS. The purpose of this session is to present economic analyses and to stimulate discussion on the impact of the CAIS program. The presentations will provide applied analyses related to the effectiveness of CAIS in stabilizing farm incomes, the implications of CAIS on crop insurance enrolment, and the optimal deposits under CAIS.

WHAT'S GOING ON IN CONSUMER BEHAVIOUR?

Session Organizer: Ellen Goddard, University of Alberta

Consumer behaviour remains an evolving and fascinating area of research. In this session the papers presented cover some of the many methods being investigated to improve the quality of consumer analysis. Government attempts to deal with the social costs of poor nutrition and to deal with consumer understanding of new technologies can be enhanced through enriched understanding of what triggers consumer response. Areas in which both the policy process and the economic theory can be improved will be highlighted.

INVITED SESSION 2:

EXPERIMENTAL ECONOMICS: MOVING FORWARD WITH APPLICATIONS TO ENVIRONMENTAL AND RESOURCE ISSUES.

This session highlights the research of two of the Northeast's young faculty, Jim Murphy and Chris Anderson. Professors Anderson and Murphy will discuss why economists run experiments, and present examples of problems in environmental and natural resource economics which have been or could be addressed experimentally. They will demonstrate the technique with an experiment in which *punctual audience members will have a chance to earn \$100*.

Hypothetical Bias and Contingent Valuation: What's Going on Here? - Dr. James Murphy, Department of Resource Economics, University of Massachusetts.

The presence of hypothetical bias in contingent valuation is well documented, and some calibration techniques have been successful at reducing or removing this bias. However, the underlying causes of hypothetical bias are not well understood. Recent efforts to use laboratory experiments to test hypotheses about potential sources of this bias will be presented. PRINCIPAL PAPER SESSION (4) THE ECONOMICS OF THE CANADIAN AGRICULTURAL INCOME SUPPORT PROGRAM

Session Organizer: Al Mussell, George Morris Centre

Rationale:

The Canadian Agricultural Income Support (CAIS) program, implemented under the Business Risk Management pillar of the federal-provincial Agricultural Policy Framework (APF), represents a major shift in Canadian farm safety net policy. Under CAIS, the two leading safety net programs (NISA and CFIP) and provincial companion programs are collapsed into a single program. The measure of farm income that is used to trigger support is changed from gross margin to "production margin", calculated on an accrual basis rather than on a cash basis. Producers must make a deposit into a safety net account under CAIS, however the deposit is fundamentally different than that under NISA. Unlike NISA, the same measure of income is used to establish both the level of producer deposits and trigger withdrawals. Finally, at a fundamental level, a farmer must experience an income loss to trigger government support under CAIS, unlike NISA. Thus, there are material differences between the new CAIS program and its predecessors. However, little is known about the incentives, effectiveness, or effects that will result from CAIS. The purpose of this session is to present economic analyses and to stimulate discussion on the impact of the CAIS program. The presentations will provide applied analyses related to the effectiveness of CAIS in stabilizing farm incomes, the implications of CAIS on crop insurance enrolment, and the optimal deposits under CAIS.
