The Workshop explores the policy responses to crises in agricultural and resource economies in an effort to better understand the impact that these policies have had and to improve policy formulation in the future. Some examples of the types of issues explored included: Mountain Pine Beetle; BSE; Avian Influenza; PVYn; Water Crisis (Walkerton); Foot and Mouth Disease; etc.
