2024 ANNUAL MEETING SUMMARY

The 2024 CAES Annual Meeting (Congrès annuel SCAÉ 2024) was held at the historic Fort Garry Hotel in downtown Winnipeg from July 7 to 9, 2024. The meeting attracted 95 registered participants.

The conference commenced with the Presidential Address by Dr. Yu Na Lee (University of Guelph), who spoke on nutrition inequality and the role of food policy in promoting healthy eating. This was followed by a welcome reception in the beautiful Grand Ballroom of the Fort Garry Hotel. On the morning of July 8, Dr. Ellen Goddard (University of Alberta) delivered the Fellows Address, providing an insightful overview of the history of economic analysis of food demand in Canada and discussing the evolution of publicly accessible data to address these issues. We continued the Graduate Student Paper Competition, where three finalists presented their research to a panel of judges. Dr. Mary Doidge (McGill University), Dr. Alfons Weersink (University of Guelph), and Dr. Xiaoli Fan (University of Alberta) graciously served as judges. The winner of the competition was celebrated at the Awards Banquet on July 8.

In the morning of July 9, keynote speaker Dr. Madhu Khanna (University of Illinois) delivered a talk on the role of artificial intelligence (AI) and digital technologies in sustainable agriculture. Her presentation provided an engaging overview of the current applications of AI-enabled technologies in agriculture and highlighted their implications for farmers' decision-making and the economic models that inform their incentives for adoption. In the afternoon, the Focus on Fellows session, chaired by Dr. Jill Hobbs (University of Saskatchewan), featured three CAES Fellows—Dr. William Kerr (University of Saskatchewan), Dr. James Vercammen (University of British Columbia), and Dr. Alan Ker (Michigan State University)—who each discussed the issue of volatility in Canadian agricultural markets from various perspectives. Additionally, the Annual Meeting included two organized symposia and 14 selected paper sessions covering a wide range of topics.

Poster preparation

Posters should be designed for a non-academic audience, with a focus on the policy rationale and implications of your research.

While adhering to the typical research structure (background, objectives, methods, results), keep in mind the broader policy context. If you plan to submit virtually, in addition to submitting a PDF file of your poster, please create a 2-minute video presentation of your poster, as if you were addressing a live audience, either using Zoom or as a voice-over in PowerPoint. This video, along with the poster, will be uploaded to the conference website. For those attending in person, posters will be displayed on poster boards, and you can directly interact with conference attendees to answer questions.

The competition will be evaluated by a panel of judges, including academics, government representatives, and industry experts, with input from conference attendees.
