Food affordability and supply chain resilience in turbulent times

Jill Hobbs, University of Saskatchewan

Canada remains a major agri-food exporter, yet food affordability has become a top-of-mind issue for many Canadians. Food affordability is driven by food prices, household incomes, and (for some communities) access and availability. Drivers of food price inflation and sources of vulnerability are discussed. Supply chains are facing disruptions on multiple fronts due to geopolitical uncertainty, climate and weather shocks, transportation and logistics bottlenecks. How do we define supply chain resilience in a Canadian context, what makes supply chains more (less) resilient, and what factors currently threaten resiliency? What key policy implications arise and how can agricultural economists contribute to the debate?

Tariffs, Tariff Responses and Flawed Trade and Domestic Institutions

Bruno Larue, Université Laval

The standard economics of trade agreements and trade wars are being challenged by current events. Long standing regional and multilateral institutions meant to curb opportunistic behavior appear powerless. I will discuss tariff settings when governments pursue different objectives and constraints, including constraints imposed by domestic institutions.

Distributional Inference: Moments versus Quantiles

Alan Ker, Michigan State University

It is becoming more prevalent in the literature to make distributional inferences from moment based regressions. We illustrate that upper moment changes (i.e. skewness, kurtosis, etc.) are not monotonic with respect to mass shifts thus severely complicating distributional inferences from moment based regressions. We contrast this with distributional inferences made from quantile regressions.

International Trade Models in 2026: Results, Assumptions and Data

Bruno Larue, Université Laval

I review key results from international trade models commonly used to make inferences about the pattern and the volume of trade and the gains from trade. I argue that some popular results ought to be downplayed while new insights can be gained from using more realistic assumptions. I question the transfer of assumptions suitable for 1-sector and 2-sector trade models to sectoral trade models, the kind mainly used in agricultural economics. I also discuss theoretical and empirical issues in trade policy analysis, including data issues.

Keynote Address: Jill Hobbs, University of Saskatchewan



Dr. Jill E. Hobbs is a Distinguished Professor in the Department of Agricultural and Resource Economics at the University of Saskatchewan. Her research encompasses agri-food supply chains, consumer behaviour, and food policy. Recent research has focused on supply chain resilience in the agri-food sector, sustainability labelling and certification in food markets, and international regulation of gene-edited agri-foods. Dr. Hobbs earned her Ph.D. from the University of Aberdeen. She holds an M.A. in Economics from the University of Calgary and a B.Sc. (Econ) from Aberystwyth University. Dr. Hobbs was appointed a Fellow of the Canadian Agricultural Economics Society in 2017 and an Honorary Life Member of the International Association of Agricultural Economists in 2024.

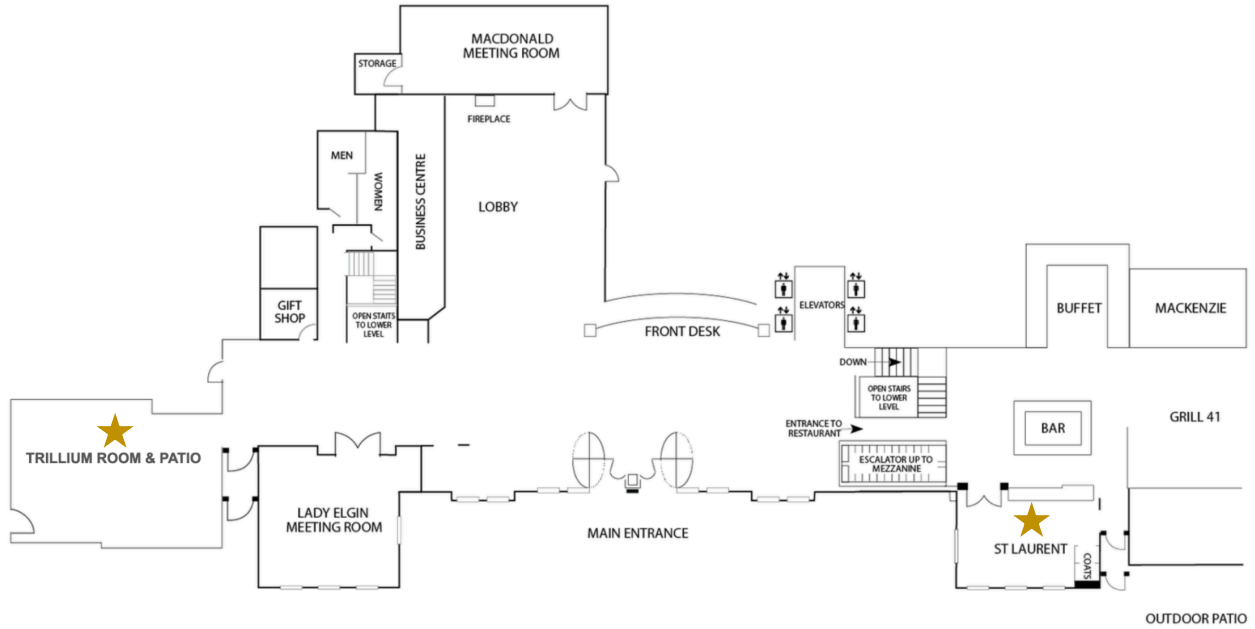
